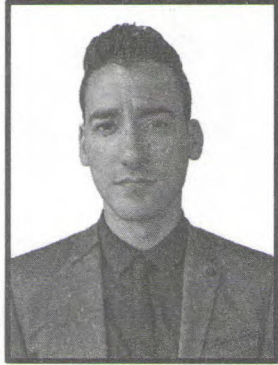


My undercover videos exposed Planned Parenthood's illegal trafficking in baby parts.

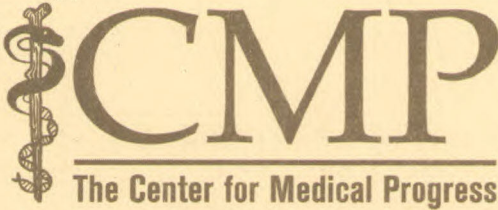
