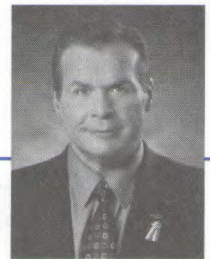


Cease and Desist Notice


